

First Baptist Church of Mansfield 2014 Parking Policy

Please read through this information concerning parking at the First Baptist Church of Mansfield.

Parking Policy:

The parking agreement is for the benefit of both the individual and the church, we are not a parking business. We realize that there is a need to use the church parking lot and we ask that you respect the needs of the church and we will treat you and your car with respect. We ask that individuals who use our parking lot consider giving back through financial donations or volunteering during the year.

Important Points to Parking at FBCM

Winter Parking: Our parking lot is plowed commercially please respect the effort we put into keeping our lot cleared. If your car is plowed in it is your responsibility to clear the area surrounding your car and put the snow appropriately off the lot.

Safe Driving: No inappropriate driving or disrespectful behavior will be tolerated. You will be asked not to park here any longer.

Parking Pass Info: Parkers will be issued a “pass”. You can pick up the pass when you first come to park. Your car/license plate will also be registered with the church. Either way, please introduce yourself, we like to meet each parker. **Keep your “pass” visible.** Your “pass” is **not transferable** to other cars.

BEFORE you fill out the Application:

The one requirement to parking at FBCM: If you are not attending worship on Sunday mornings then we ask that you free up the church lot for those who do attend our worship service. **Our worship service starts at 10:45 am** Sunday.
